INVITATION TO BIDDERS**

Notice is hereby given that the Commissioners Court of Briscoe County will accept bids relating to the County Transportation Infrastructure Fund grant projects listed below. Bids will be publicly opened and read aloud in the Commissioner Courtroom, on Monday, October 11, 2021 at 9:00 Central Time, during the Regular Term Meeting, for the following:

**STORM PIPE (CULVERT) SPECIFICATION**

This bid is for storm pipe (culverts) for use with county road drainage (gravity-flow storm drainage applications). The pipe shall have a smooth interior and annular exterior corrugations and meet or exceed ASTM F2881 and AASHTO M330. Polypropylene compound for pipe and fitting production shall be impact modified copolymer meeting the material requirements of ASTM F2881, Section 5 and AASHTO M330, Section 6.1.

Bids must include and separately state any additional costs, charges, or fees (freight, fuel, hauling, loading, unloading, personnel, etc.) that relate to this bid and for which the bidder expects compensation. Any such unstated costs will not be paid by the County and failure to state such costs will not relieve a successful bidder from performance.

All pipe shall have the following additional specifications:

- 20' Bell x Spigot Joint, 30' Plain End Joint


