Meeting was called to order at 9:00 a.m. by Judge Wayne Nance.

Open Forum: Commissioner Wellman asked to have a TAC representative present at the next meeting to discuss a personnel policy. Judge Nance informed the court that a company was to look at the courthouse interior lights and work up a bid for replacement.

Motion was made by Commissioner Wellman to purchase a 2005 Freightliner Columbia truck with a Belly Dump trailer from Pan Cor Construction for \$25,000. Cost will come out of each of the 4 precincts Equipment line item. Second by Commissioner Francis and passed with a 5-0 vote, it is so ordered.
