INVITATION TO BIDDERS

Pursuant to Section 262.025 of the Texas Local Government Code, notice is hereby given that Briscoe County will receive bids, as described below, until Friday, April 9, 2021, 5:00 p.m. Central Time in the office of the County Judge, Briscoe County Courthouse, P.O. Box 153, Silvertown, Texas, 79257. Bids received after the after the specified time will be returned unopened.

Bids shall include this invitation to bid and all additional documents submitted. Each bid shall be placed in a separate sealed envelope, manually signed in ink by a person having the authority to bind the bidder in a contract and marked clearly on the outside as indicated. Facsimile transmittals will not be accepted.

The bids received will be publicly opened and read aloud in the Commissioners Courtroom, at 415 Main Street, Silvertown, Texas, during the Regular Term Meeting, to be held on Monday, April 12, 2021, 9:00 a.m. Central Time, and will be awarded to the lowest responsible bidder. Multiple bids may be awarded. Briscoe County reserves the right to reject all bids.

COUNTY TRANSPORTATION INFRASTRUCTURE FUND GRANT (CTIF) – 2021 MATERIAL BID

This is a materials-only bid for pit-run road material (caliche). This bid is to supply material to Briscoe County for one year from the award date. Materials to be bid by the yard. No minimum quantities are guaranteed.

Briscoe County will excavate, load and haul the material. Distance from bidders' sites and project worksite(s) may be considered in awarding bids. Bids will be awarded to the lowest responsible bidder for all projects, if a single bid, or individual projects, as submitted.

Material desired must be suitable for road construction and maintenance. The Commissioner Danny Francis will judge the quality and suitability of the material. Bidders should have their pits approved before the bid date. Bidders can contact Commissioner Danny Francis at (806) 292-2034 to set up an appointment for inspection. It is understood that quality of material purchased may vary by location.


