Motion was made by Commissioner Wellman to approve the purchase of a command trailer for the Sheriff's Department in the amount of \$7,600 from Coffman Industries, Inc. \$4,000 will come from the sale of old patrol units and the remaining \$3,600 will come from the unused Deputy 2 salary. Seconded by Commissioner Burson, passed with a 4-0 vote, Absent Commissioner Francis, it is so ordered.
